# 7. 46/25 Reports from County and Borough Councillors

Cllr Izett reported via Teams:

#### Oakley Farm 500 house development- Background

- BDBC Draft Local Plan proposes 500 homes on Oakley Farm (Highclere).
- Came as a shock "bolt from the blue."
- Originally only 96 homes (36 + 60) suggested; now escalated to 500.
- Triggered by increased housing targets: +40% for Basingstoke (≈6,000 homes).
- Oakley Farm only put forward at end of last year.

#### **Resident Concerns**

- Many residents unaware; limited contact so far.
- Area is a small lane; community feels blindsided.
- Concerns:
  - o Hundreds of houses would border their homes.
  - Heritage context (farm history, listed buildings).
  - o Infrastructure (schools, doctors, buses) already under strain.
  - o Feels like a "forgotten corner" of Basingstoke/West Berks.

## **Developer/Promoter**

- Promoter approached farm owners; contract signed to push development.
- Parish unsure which promoter but likely a known local one.

## **Planning & Political Context**

- Previous local plan rejected by government.
- New "spatial strategy" drafted: most sites examined before, but Oakley Farm is new.
- Goes to Basingstoke Cabinet in November, then public consultation (Nov–Dec).
- Timeline driven by need to submit plan to inspector before 2027 rule changes.

#### **Parish Response**

- Must act quickly (before November cabinet).
- Opposition must focus on planning arguments, not just protests.
- Suggested: hire planning consultant/expert to strengthen case.
- Look for "showstoppers": e.g., listed buildings, inspector's past rejection of Oakley Farm/Falkland Farm.

#### **Cross-Border Issues**

- Development positioned as "suburb of Newbury."
- Would rely on West Berks for infrastructure (schools, GP, buses).
- Opportunity: partner with West Berks councillors, who are also opposed.

#### **Other Parish Considerations**

- Publicity: residents not well-informed.
  - o Suggest newsletter, Facebook, Highclere Society updates.
  - o Possible public meeting at the Woodpecker pub.
- Enborne PC not yet fully aware.
- Invite Joanne Brombley (planning officer) to parish for consultation.

## **Additional Updates**

- Highgates: ongoing illegal builds, enforcement still delayed.
- Bus services: 7A/7 routes cut (Sept). Parish lobbying Basingstoke for funding, tied to Oakley Farm argument.
- Local Government Reorganisation:
  - o 12 councils propose 4 unitaries (+Isle of Wight as 5th).
  - o Hampshire/East Hants propose 3 unitaries.
  - o To be decided by Secretary of State (2026 target).

## **Key recommendations**

- 1. Contact planning consultant quickly to investigate planning/legal grounds for rejection (heritage, inspector history, infrastructure shortfall).
- 2. Raise objections before November cabinet meeting.
- 3. Coordinate with West Berks councillors.
- 4. Inform parish residents

# 7 47/25 Neighbourhood Plan update

Colin Wall reported on a discussion with Planet: It is more than likely that the NP will have to update its housing figures from 10 to 20- the new recommendation in the draft Local Plan. A new environmental assessment may be required- this could take another four to five months. Overall much of the NP is on hold until the Local Plan is approved.

# 8 48/25 Planning

Watermill Bridge: Cllr Falconer gave a brief update after an earlier meeting with Emily Woods, Bewley Homes on 23 September 2025:

Reserved matters will be submitted in October, with the build commencing in approx. one year's time. The whole build is likely to take 7-8 years to complete. Concerns were raised about Thames Water, and the fact that the parish is actually under Berkshire NHS Trust, even though the money will be given to Hampshire, as well as concerns over money given for schools etc. Emily will provide a Q&A document to the Clerk from this meeting which the Clerk will disseminate.
